

AIA VITALITY HEALTH CHECK COMPETITION

TERMS AND CONDITIONS OF ENTRY

GENERAL

1. Information on how to enter and prizes form part of the Terms and Conditions of Entry. Entry into this competition is deemed acceptance of these Terms and Conditions.
2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

WHO CAN ENTER

3. Subject to the clauses below, entry is open to all residents of Australia who have fulfilled the requirements set out below (**'Eligible Entrants'**).
4. Any entrant who is under the age of 18, as of the date of entry, must obtain the prior permission of their legal parent or guardian over the age of 18 to enter. The parent or guardian may be called to verify their consent and may be required to sign a release at the discretion of the Promoter. The release may also require the entrant's parent or guardian to accept responsibility for the acts and forbearances of the entrant. The release must be completed with the full name, address and telephone number of the entrant's parent or guardian.  - Hold an activated AIA Vitality membership.
 - Complete a free full AIA Vitality Health Check – consisting of four tests, including: Body Mass Index, Blood Pressure, Cholesterol and Random Blood Glucose - at a participating pharmacy partner, or with a General Practitioner or other suitable health professional (at their cost) and submit their results through their AIA Vitality member portal or mobile application between 01 Nov 2021 - 31 Jan 2022. AIA Vitality members are eligible to receive only one free AIA Vitality Health Check at a participating pharmacy partner, once per membership year, with any additional AIA Vitality Health Checks performed at a participating pharmacy partner done so at a member's cost.
7. By submitting an entry into this competition entrants consent to receive promotional and other marketing messages from the Promoter (including messages sent electronically for an unlimited period of time). Entrants will be able to opt-out at any time by following the instructions included in each message sent by the Promoter.

8. Entries must provide contact details on request to be eligible to win. Entrants may only enter in their own name. Inaudible, incomprehensible, illegible, and incomplete entries may be deemed invalid.

NUMBER OF ENTRIES PERMITTED

9. Only one entry per person will be permitted. Entrants found to be submitting multiple entries may have all entries invalidated.

10. The competition commences on **18/11/2021** at **12:01 AM** and closes **31/01/2022** at **11:59 PM** ('Promotional Period'). All times noted in these Terms and Conditions are local times, based on the location of the Promoter. If any draw date falls on a public holiday, as defined in the state of the Promoter, that draw will be conducted on the next business day. Entries must be received by the Promoter prior to the competition close date and time.
